PRESCHOOL FINANCIAL ASSISTANCE

Preschool financial assistance may be available to qualifying families through your county's Early Childhood Iowa. Families must meet income guidelines to qualify. Families below the income levels are encouraged to apply, but assistance is not guaranteed at these income levels. Assistance is determined by your county's Early Childhood Iowa Program in August. Community Lutheran School does not determine preschool scholarship amounts.

K-12 FINANCIAL ASSISTANCE & SAVINGS PROGRAMS

Iowa Education Savings Accounts (ESAs)

ESAs are available to all K-12 students (regardless of income) who are residents of Iowa and attend an accredited non-public school. Applications must be completed by the Iowa deadline of June 30. The amount of an Iowa ESA for 2026/2027 is \$8,148.

Iowa 529 Accounts

Iowa 529 accounts can be used to fund K-12 tuition paid to an accredited State of Iowa school. A 529 Plan is an after-tax investment account that grows tax free if distributions are used for qualified educational expenses. The State of Iowa guidelines state that the maximum 529 distribution per K-12 student is \$20,000 per calendar year and payment can only be applied towards tuition. Learn more at www.isave529.com.

Iowa Tuition Credit

Families can claim a credit of up to \$500 per child for tuition on their State of Iowa income tax return. Use your tuition statement as proof of payment. Please ask your financial advisor for more information on your specific tax situation and eligibility.

Iowa Lutheran School Tuition Organization (ILSTO) Scholarships

Community Lutheran School K-12 students are eligible to apply for needs-based scholarships. Eligibility is determined by the ILSTO. Apply online at www.iowalutheransto.com.
